I further request you to authorize your Nodal Officer to delete the affiliated colleges which are not functioning in your jurisdiction during the academic year 2017-18 from the AISHE portal using Institution Management head (sub-head De-Affiliate).

You may also arrange to decline the examination application forms of such institution which have not enclosed the copy of the certificate issued by MHRD after uploading the HE data. This programme is also having a bearing on the State position in its Gross Enrolment Ratio (GER) at National level.

Therefore, I solicit your support and active participation to achieve 100% upload of HE data in the State of Telangana.
