Sub: TU–NZB–2021–Establishment–University Teachers–Career Advancement Scheme–Applications called for from the eligible University Teachers recruited under the Direct Recruitment Notifications vide 1/2006, Dt: 08-09-2006, 1/2007, Dt: 12-12-2007, 1/2008, Dt: 01-02-2008, 1/BV/2009, Dt: 24-02-2009 and 2/2009, Dt: 24-02-2009 for award of next Academic Level/Promotions under UGC Regulations-2010 (4th Amendment-2016) or UGC Regulations-2018–Circular–Issued.

In pursuance of the approval accorded by the Executive Council of the University at its 52nd Meeting held on 12-02-2021 (Ref.5) and with the approval of the Hon'ble Vice-Chancellor (Ref.4), applications (in quadruplicate) are invited from the eligible teachers of this University who were recruited under Direct Recruitment vide “**TU Notification No.1/2006 Dt: 08-09-2006, No.1/2007 Dt: 12-12-2007, No.1/2008 Dt: 01-02-2008, No.1/BV/2009 Dt: 24-02-2009 and No.2/2009 Dt: 24-02-2009**” in the prescribed proforma for award of next higher Academic Level/Promotion to the next higher posts (as detailed below) under Career Advancement Scheme as per the eligibility criteria as outlined and prescribed in the GOs and the UGC Regulations referred to above (under the Reference).

- (i) Assistant Professor with Academic Level 12–Pay Scale: Rs.79800-211500
[Corresponding to Asst. Professor with AGP Rs. 8000 under UGC Scales of Pay, 2006]
- (ii) Associate Professor with Academic Level 13A–Pay Scale: Rs.131400-217100
[Corresponding to Assoc. Professor with AGP Rs.9000 under UGC Scales of Pay, 2006]

The teachers who were appointed vide University Notifications quoted above and who become eligible as on 31-03-2021 or before and fulfill other requirements as per the rules in force shall only apply in response to this Circular. The applications duly filled in along with all supporting and verifiable documents should be submitted through proper channel in the Office of the undersigned on or before 31-03-2021. Applications of ineligible teachers and those submitted later than 31-03-2021 and those applications submitted without supporting and verifiable documents shall summarily be rejected. Applications received without proper and supporting documents shall not be scrutinised. Applications received from the teachers shall be considered as per the rules in force and subject to the fulfillment of eligibility criteria as per the GOs and UGC Regulations referred to above. The teachers are informed to refer to the GOs and the UGC Regulations referred to above for comprehensive information and for more details on CAS promotions/award of higher Academic Level. The teachers are requested to exercise their option whether to be considered under the previous Regulations/GO (Ref 1 & 6) or UGC Regulations 2018/GO (Ref 2) as the case may be while submitting their application forms.

Further, one of the conditions for Up-Gradation / Promotion under in terms of the para 2.8 of part-II of the Annexure to the G.O.Ms. No. 15, Higher Education (UE-II) Department, Dt: 29-06-2019 cited under reference 2nd.

"The criteria for promotions under Career Advancement Scheme laid down under these Regulations shall be effective from the date of notification of these Regulations. However, to avoid hardship to those faculty members who have already qualified or are likely to qualify shortly under the existing Regulations, a choice may be given to them, for being considered for promotions under the existing Regulations. This option can be exercised only within three years from the date of notification of these Regulations."

The eligible teachers who like to apply for upgradation/promotion to the next higher academic level, either as per the previous UGC Regulations (4th Amendment Dt: 11-07-2016/G.O.Ms. No. 14 Higher Education (UE.II) Department, Dt: 20-02-2010) or as per the UGC Regulations-2018/ G.O.Ms. No. 15, Higher Education (UE-II) Department, Dt: 29-06-2019, should submit their applications in the prescribed application formats as per the regulations/guidelines concerned. (Separate Application Formats are prescribed for the old and new Regulations).

The application form, along with proforma for individual Academic Performance Indicators (API) and CAS guidelines can be downloaded from the University website www.telanganauniversity.ac.in on or after **15-03-2021**. The duly filled in application form along with necessary enclosures and a Demand Draft for Rs.250/- drawn in favour of **"THE REGISTRAR, TELANGANA UNIVERSITY, NIZAMABAD"** should reach the undersigned on or before the last date of submission i.e., **31-03-2021 by 5:00 pm**.

All the Principals of the University Campuses and Heads of the Departments are requested to bring it to the notice of all the teachers concerned as mentioned above. The incomplete applications and applications received after the last date, i.e., **31-03-2021 by 5:00 pm** will not be entertained and will be summarily rejected without entertaining any correspondence whatsoever.
