**Sub:-**Telangana University- COVID-19 Virus – Commencement of online classes in colleges - Instructions-Reg.

Higher Education (MC) Department, Government of Telangana, has issued orders vide reference cited to conduct the online classes on various digital platforms for UG and PG colleges from 1<sup>st</sup> September, 2020 in the University Colleges/Govt./Aided/ Private colleges under the jurisdiction of Telangana University. All the Teaching Staff shall attend the respective colleges regularly w.e.f. 27.08.2020 onwards and shall prepare e-content, lesson plans etc. With regard to reopening of colleges and commencement of regular classes, separate instructions will be issued as per Government of India and Government of Telangana guidelines. Until then, all the University Colleges/Govt./Aided/ Private colleges under the jurisdiction of Telangana University shall remain physically closed for students and classes.

In the circumstances, all the Principals of University Colleges/Govt./Aided/Private colleges under Jurisdiction of Telangana University shall follow the said instructions. Further, the Principals of the respective Institutions are hereby informed to take necessary action and submit a compliance report.

In the references 1<sup>st</sup> & 2<sup>nd</sup> cited, Government issued orders for extension of lockdown in containment zones till 31<sup>st</sup> August, 2020 alongwith guidelines to be followed to re-open prohibited activities in a phased manner in areas outside containment zones. The guidelines, inter alia, state that the schools, colleges, educational and coaching institutions will remain closed till 31<sup>st</sup> August, 2020.

2. Government, after careful examination, hereby issue following instructions on commence admissions and online classes on various digital/TV/T-SAT platforms from 1<sup>st</sup> September,2020 in all colleges:-

- a) Government in principle decide to conduct all Common Entrance Tests. The Commissioner of Collegiate Education is directed to coordinate with Telangana State Council of Higher Education for proper conduct of Examinations. With reference to Kaloji Narayana Rao University of Health Sciences, the Vice Chancellor of the above University is requested to take necessary action as per his proposal already submitted.
- b) Government also Permit as part of e-learning and Distance Education, online classes on various digital/TV/T-SAT platforms for 2<sup>nd</sup> year Intermediate; Degree ; PG and Professional Colleges from 1<sup>st</sup> September, 2020 in all Colleges. All the Lecturers shall attend the respective colleges regularly w.e.f. 27.08.2020 onwards and shall prepare e-content, lesson plans etc. With regard to reopening of colleges and commencement of regular classes, separate instructions will be issued as per Government of India guidelines. Until then, all colleges shall remain physically closed for students and classes.
- c) Regarding conduct of UG/PG exams, these dates will be decided based on outcome of the case, which is pending before the Hon'ble Supreme Court of India.
- d) DOST admissions to UG programmes can commence and the Commissioner of Collegiate Education to take necessary action.

3. The Commissioner of Intermediate Education ; Commissioner of Collegiate Education ; Commissioner of Technical Education ; Secretary, Telangana State Council of Higher Education ; Secretary, State Board of Technical Education & Training ; Secretary, Board of Intermediate Education ; All Registrars of Universities under control of Higher Education Department and Registrar, Kaloji Narayana Rao University of Health Sciences, Warangal are requested to issue detailed operational guidelines in this regard.
