5. Three Governing Body Meeting reports of the Academic Year 2018-19.
6. Compliance Report forwarded by Governing Body Member.

Commencement of Inspection of Colleges to extend Provisional Affiliation for the Academic Year 2019-20 is from 25<sup>th</sup> March, 2019 as per the enclosed schedule.
